• Community Economic Resilience Fund (CERF) Discussion

The State of California is ramping up efforts to design and deliver \$600 million worth of regional grants to promote a sustainable and equitable recovery from the economic distress of COVID-19. The grants will be used in two phases. The first phase is to be used for regional planning purposes to establish new, inclusive regional planning tables starting in spring/summer of 2022 and to develop localized integrated recovery and transition plans for each region. The second phase will be grants to regions to fund key sectors and projects that were identified and developed during the planning phase. Discussion will be facilitated around the WIB's position and role as well as possible strategies to ensure that Tulare County is well represented within the regional planning phase."
