EXECUTIVE SUMMARY:

This policy memo provides guidance and processes for determining an individual's low-income eligibility for the WIOA Title I Youth Program using a set of pre-determined contiguous census tracts.

This policy memo contains no state-imposed requirements.

Effective immediately, all subrecipients must follow the steps outlined in this policy memo when determining Youth low-income eligibility based on high poverty.

DURATION:

This policy memo is in effect until January 31, 2028 or within fourty-five days following the release of the 2026 American Community Survey (ACS) 5-year data.

The WIB will determine a set of contiguous census tracts for Tulare County with a poverty rate of at least 25 percent every five years, as set every five years using the ACS 5-year data and review the data annually.

BACKGROUND:

WIOA Title I Youth Program Section 129(a)(2), Special Rule, includes a provision that allows inschool (ISY) and out-of-school youth (OSY) living in high-poverty areas to meet the low-income eligibility criterion automatically. Title 20 in the Code of Federal Regulations (CFR) 681.260 defines a high-poverty area as a census tract, a set of contiguous census tracts, an American Indian Reservation, or other tribal land as defined by the US Secretary of Labor in guidance, or a county that has a poverty rate of at least 25 percent, as set every five years using American Community Survey (ACS) five-year data.

POLICY AND PROCEDURES:

Historically, the poverty rate in Tulare County was above 25 percent (high-poverty) until December 10, 2020, when the 2019 ACS 5-year Census data was released. Therefore, any Youth eligibility based on living in a high-poverty area before the release of the 2019 ACS 5-year Census data would have automatically met the low-income eligibility criterion.

The poverty rate fell below 25 percent with the release of the 2019 ACS 5-year Census data, released on December 10, 2020. As of that date, Youth applicants in Tulare County were no longer automatically qualify as low-income based on living in a high-poverty area unless their census tract had a poverty rate at or above 25 percent.

Contiguous Census Tracts Determination

Following the release of the 2021 ACS 5-year Census data on December 8, 2022, the WIB has determined a set of contiguous census tracts in Tulare County totaling a poverty rate of 25 percent or above.

The set of contiguous census tracts determined by the WIB is a result of guidance provided by the U.S. Department of Labor's Employment and Training Administration, TEGL 21-16, and its corresponding attachments. Tulare County has 103 census tracts with a population of 464,801 and a poverty level of 19.76 percent. The contiguous tract data set, located in Attachment B, Table 1, has been identified to include 72 census tracts with an overall poverty level of 25.0 percent and a population of 310,750 throughout Tulare County. The 30 census tracts not included in the contiguous tract data set have a poverty rate of 8.78 percent and a population of 150,971 within Tulare County can be found in Attachment B, Table 2.

There is one stand-alone census tract number (20.08) not connected to the set of contiguous census tracts in Attachment B, Table 1. The census tract is above the 25 percent (high-poverty) threshold, automatically qualifying as low-income based on living in high poverty tract number, therefore included in this report. This census tract was not used to calculate the poverty rate of the WIB determined set of contiguous census tracts.

The poverty rate for the set of contiguous census tracts was calculated by adding the total population of each selected census tract for whom poverty status is determined, divided by the total population below the poverty level.

Census tracts listed in Attachment B, Table 1 have been determined by the WIB to be high-poverty areas based on contiguous census data. The contiguous census tracts found in Table 1 are to be used for an eligibility determination to verify if a youth is automatically considered to be a low-income individual living in a high-poverty area. If an individual is verified as automatically high poverty, the verification of tract number based on home address must be documented with a case note in the participant's CalJOBS file.

Census tracts found in Attachment B, Table 2 are not within the contiguous census tracts identified by the WIB. Therefore these census tracts are not considered to be within a high-poverty area and other methods of eligibility to determine low-income should be conducted for individuals living in one of the census tracts in Table 2.

Instructions on how to find a census tract number based on an individual's address can be found in Attachment A.



How to Determine a Census Tract Number


Section 1: Determining if an Individual Lives in a High-Poverty Area Based on Their Street Address

On July 30, 2021, the US Department of Labor's Employment and Training Administration issued Training and Employment Guidance Letter (TEGL) No. 21-16, Change 1, titled: *Third Workforce Innovation and Opportunity Act (WIOA) Title I Youth Formula Program Guidance*. As of November 30, 2021, directions for using American Community Survey data to determine high-poverty areas are as follows: (WIB address has been used as an example for steps 1-4)

 Obtain individual's street address, and click on: https://geocoding.geo.census.gov/geocoder/geographies/address?form
 The following screen will appear.



2. Fill out the required information pertaining to the participant's address and select get results. For the following sections, do not change the setting in: Benchmark and Vintage.



- 3. The result will list the geographic coordinates and then state, county, and other geographic identifiers.
 - Scroll down to **Census Tract**. At the end of the information for census tracts there will be listed **Name**. This will give you the Census Tract number of the street address that was inputted above. The name of the Census Tract is its **number**.

4. Use the census tract number retrieved in step 3 and verify that the tract number is located in Attachment B, Table 1. If the tract number is found listed in Table 1, the individual's address has been determined by the WIB to be a part of the approved contiguous tract and is therefore found as a high-poverty tract. No further steps are required. Subrecipients will enter a case note in the participant's file and include the census tract number, and the individual's tract number

If this tract number is **not** found in Attachment B, Table 1 but is listed in Attachment B, **Table 2** refer to step 5.

5. If steps 1-5 are completed and the Census tract number indicates a poverty rate below 25 percent, <u>low-income must be determined by other methods of eligibility as determined under WIOA regulations.</u>
