##### a. Overview of the Youth Program

*WIOA Youth and Specialized Workforce Program Allocations*

- WIOA Youth Funding Priorities:  
WIOA requires no less than 75% of youth funding be used for out-of-school youth and no more than 25% be used for in-school youth.
- Emphasis on Work-based Learning:  
At least 20% of local Youth formula funds must be used for work-based learning such as:
  - Year-round employment
  - Summer employment
  - Pre-apprenticeship and Internships

- Tulare County Probation
- Foundation of Community Colleges - Students with Disabilities
- Tulare County Board of Supervisors - #LEAD
