a. Approve a recommendation to the WIB to approve the allocation for the 2026 WIOA Title I In-School Youth Services Agreement-East Region Balance of County for one year with the option to renew for two additional years at the discretion of the WIB, for the following:

- i. An allocation up to \$693,000 to Proteus Inc. to operate the WIOA Title I 2026 In-School Youth Leadership, Education and Pathways to Employment (LEAP) program at the following high schools:
 - o Dinuba High School
 - o Woodlake High School
 - o Cutler-Orosi-East Rural
 - o Tulare Western High School

Craig Plath of CSET and Michelle Engel-Silva of Proteus Inc. each provided public comments regarding this item. A full recording of their remarks is on file and available upon request.

A motion was made by Gamaliel Aguilar and second by Sandra Bullard to approve a recommendation to the WIB to approve the allocation up to \$693,000 to Proteus Inc. for the 2026 WIOA Title I In-School Youth Services agreement to operate the In-School Youth Leadership, Education and Pathways to Employment (LEAP) Program at the following high schools: Dinuba High School, Woodlake High School, Cutler-Orosi-East Rural, and Tulare Western High School, with clarification to omit the East Region Balance of County language since it's not tied to the existing agreement. A correction was made to reflect the accurate school's name as Tulare Western High School, replacing the originally listed Tulare Joint Unified High School; carried by unanimous vote.
